## GENERAL

- Each court will have bleachers for spectators. No outside chairs please.
- A tournament representative will check you in and out. Please make sure to find someone before you leave so we can assure that your area is clean and that you haven't forgotten anything!
- NO GUM on courts!
- No pets are allowed in the facility.
- Please supervise children at all times.

## Convention Center

### PARKING

During the ERVA Regional Championships, the parking garage will charge \$10 per day (subject to change), with no in and out privileges--the garage cannot accommodate oversized vehicles. There are also parking lots available around the venue that are not owned by the Spokane Convention Center. Metered parking is also an option, and is enforced until 7 pm every day except Sunday.

### FOOD/DRINK POLICY

No outside food is permitted inside the Spokane Convention Center. There will be concessions available. Bottled water WILL be allowed into the Convention Center, and ONLY non-flavored water will be allowed in the court area.

## TEAM AREAS

Team areas will be in the Foyer & Promenade (the area between the Doubletree Hotel and the Spokane Convention Center). Areas will be clearly marked and we ask that you take ONE area per team to store your team bags. Please make sure your team area is clean before leaving the site.

## ENTRY POINTS

Spectators and those participants who have not yet received their wristbands must enter through the Main Convention Center entrance and will not be allowed to enter through the Doubletree - Promenade connecting hall. All players must show their wristbands and ALL adults must be WEARING their wristbands to be admitted.

## Bid Tournament Format

- Warm-ups are 5-5 for the first two rounds of pool play, and then 3-3 after that. Serving must be done within this time.
- Top seeding in the National Bid Tournament for GJNC
  - Top 8 Power League teams will be seeded above any other teams interested in competing in the National Bid Tournament

## Pool Play

- Pool play matches are the best 2/3 with no cap. Any ties in in pool finish will be broken per guidelines in the ERVA Tournament Procedures manual.
- Pool play finishes will seed each team into a single elimination bracket.

## Tournament Play

- All tournament play matches are the best 2/3 with no cap.
- While paid, officials will be available for many matches, teams that lose in tournament play will need to supply an officiating team for the next round of play unless released by the Site Director.
- **The team winning the bracket will win the National Bid. The runner-up will win the American Bid**

## Official and Referee Information

- R1's will be provided for all pool matches and bracket play. Teams must provide R2's, line judges, and scorekeeping crews.
- Championship games of each bracket will be provided officials in the R1, R2, and line judge positions. Teams must provide scorekeeping crews.

## ERVA Bids Available for USAV GJNC:

- ERVA has two bids available for each age group. 1 National bid and 1 American bid.
- ERVA has a room block set aside with Team Travel Source for the NATIONAL bid winner only. This information will be provided to you once you accept this bid. The American bid winner will need to reserve rooms through Team Travel Source on their own.

## Prizes

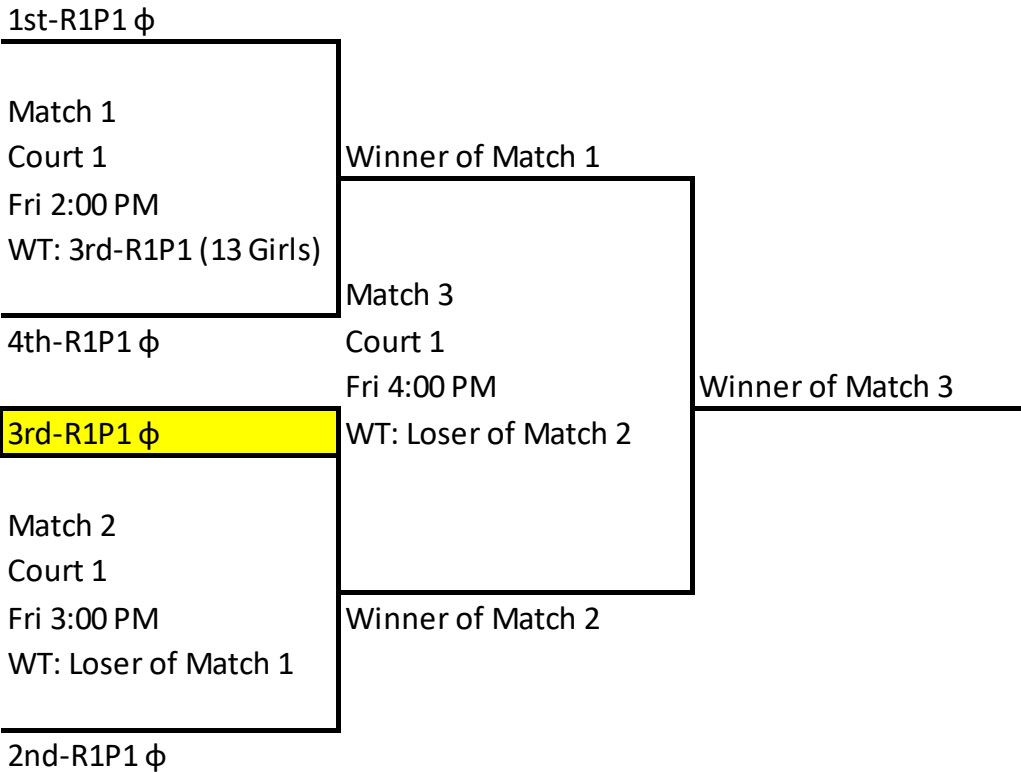
- Prizes will be awarded to the National and American Bid winners.

## U13 Bid Bracket

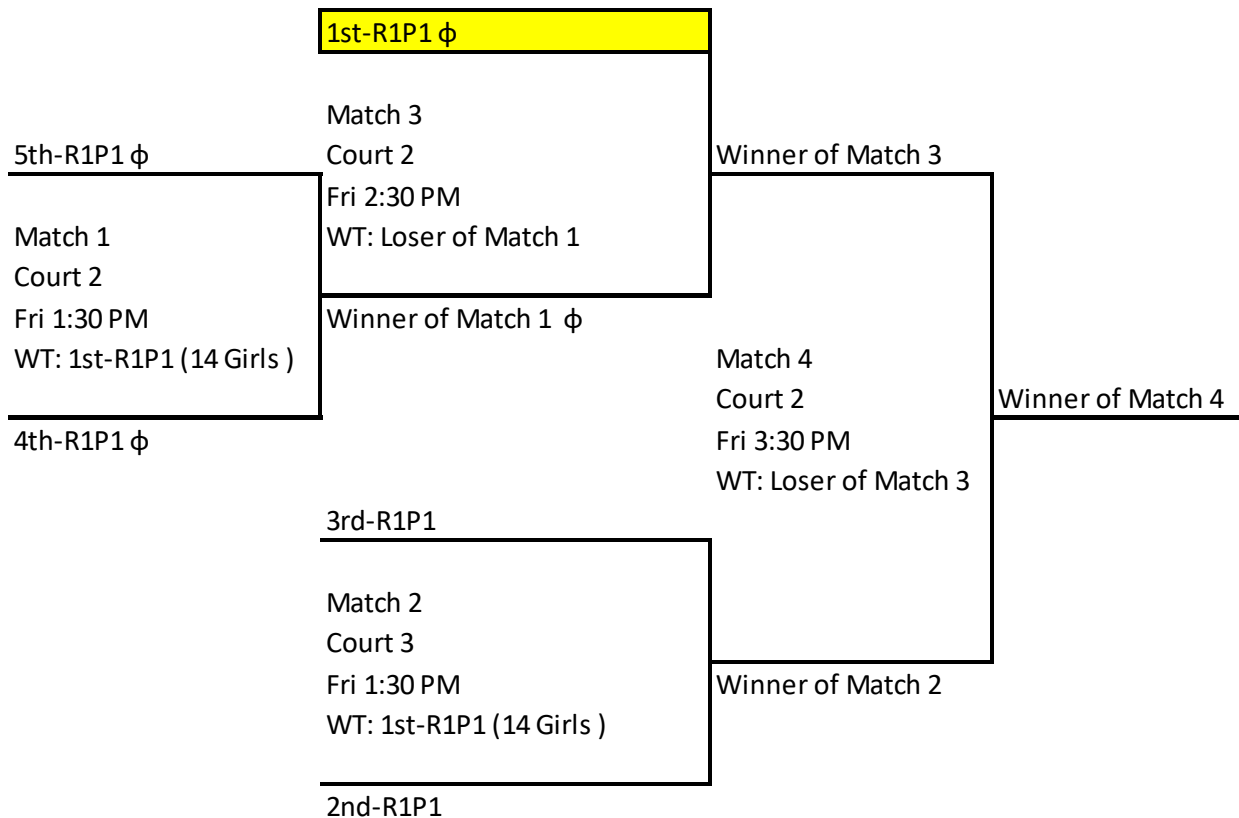

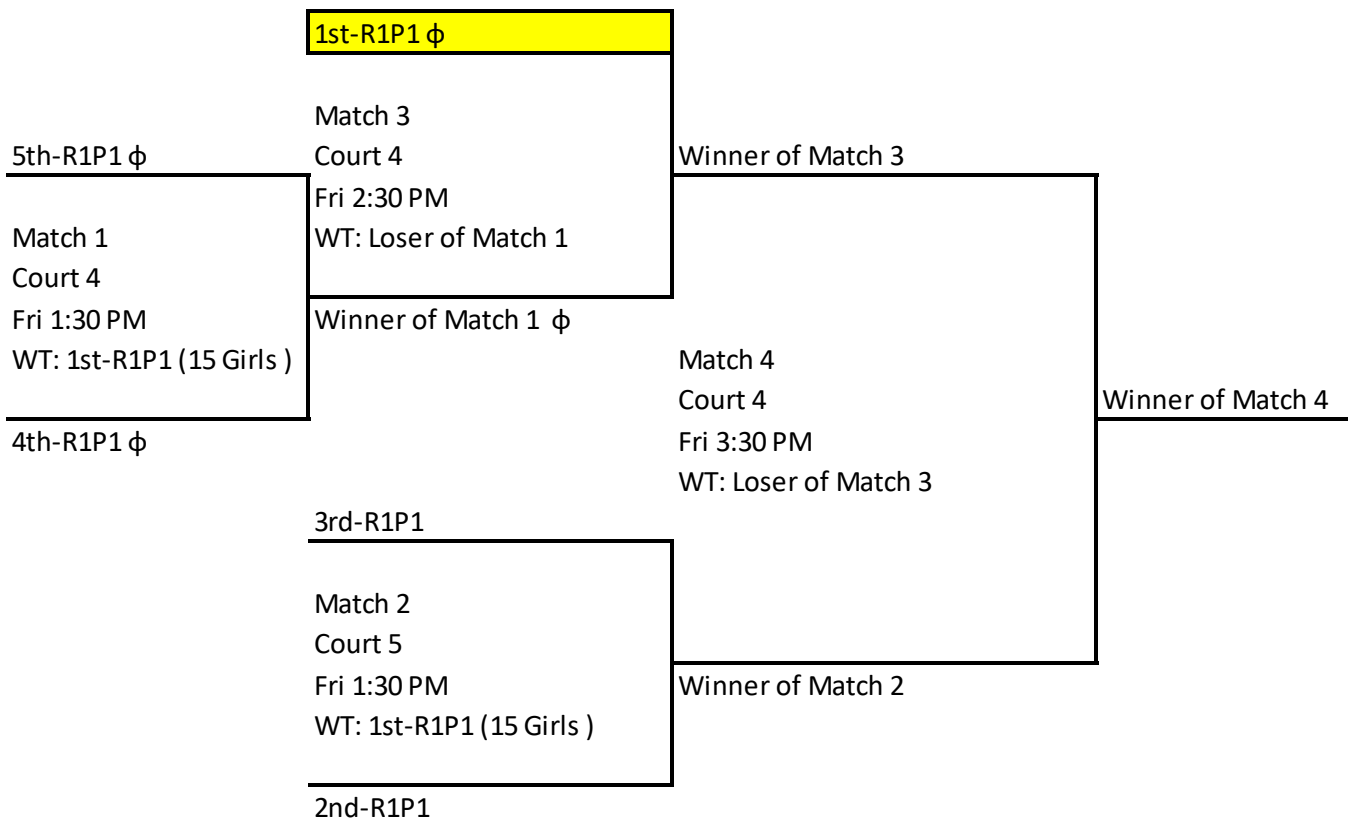

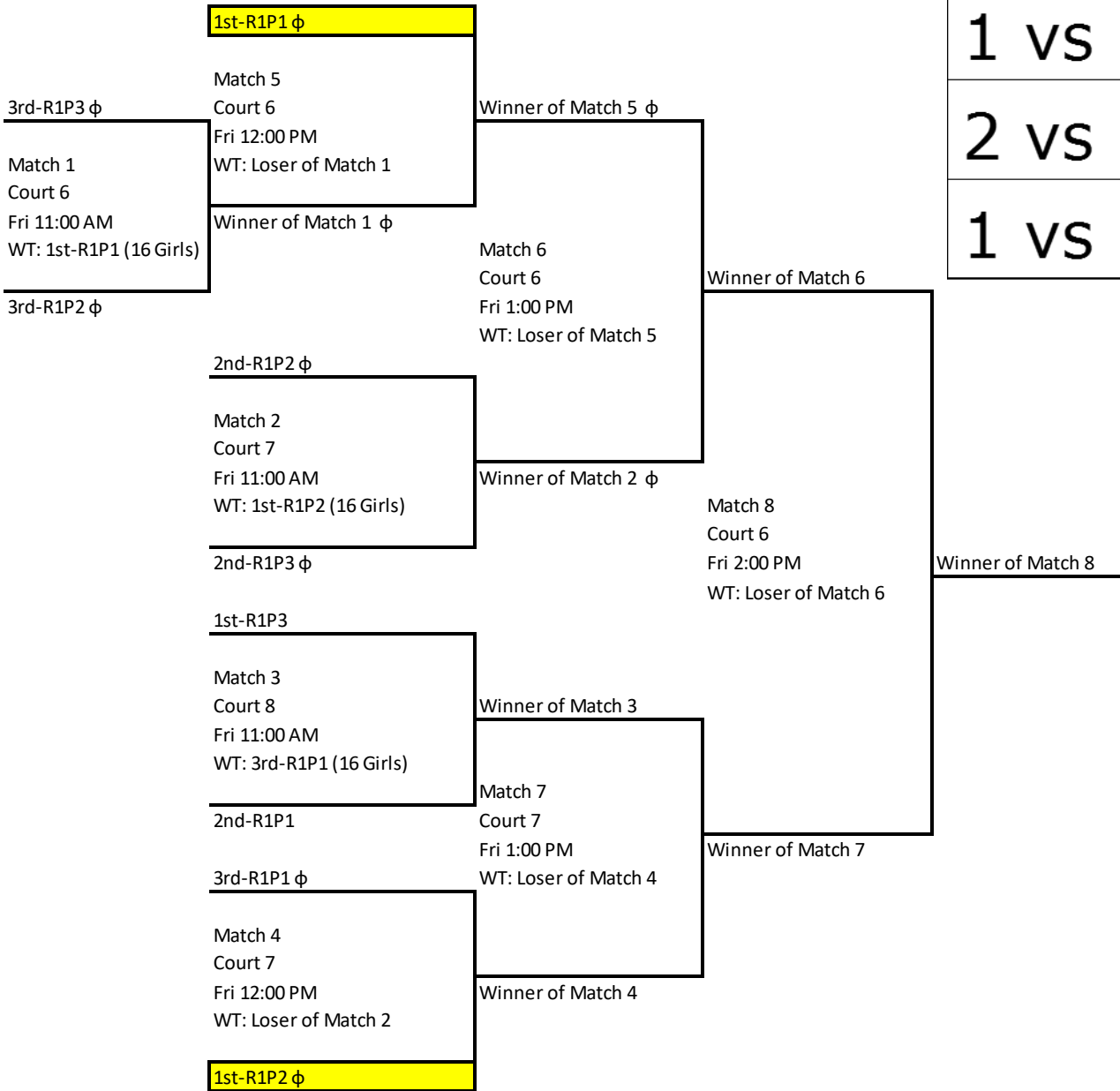
